5 Year Limited Warranty

The manufacturer, Universal Service & Repair LLC (USR), warrants all products to the original purchaser, to be free from any defects in material and/or workmanship for five years from the date of original purchase. Any part found to be defective during this period will be repaired or replaced at the discretion of USR. Any part replaced under the warranty will be covered for the remaining period of the original warranty. USR may, at its discretion make any repairs or replacements of parts, but such work shall not be deemed to be an admission of liability. USR will bear labor charges for work carried out under the warranty as all warranty work is done in house by USR at our factory location. The warranty may not be transferred to subsequent owners for the balance of the remaining warranty period.

The following conditions and exclusions apply:

1. The warranty does not cover defects which have not been reported to the manufacturer, immediate upon discovery of the defect.
2. The product must not have been subject to any modification, replacement, or repairs other than as authorized by the manufacturer USR.
3. Defects caused by faulty adjustment, neglect, or repairs and alterations performed by anyone other than USR are not covered by the limited warranty.
4. The hydraulic jack is not covered under this warranty. (USR does not manufacture this product. We can assist in replacement parts at the manufactures costs)
5. The product must not have been misused, inadequately maintained, incorrectly serviced, or used for competition.
6. The warranty does not cover products used on a commercial basis.
7. The warranty does not cover damages due to abuse, misuse, accident, or use of unauthorized attachments or modifications.
8. Painted finish will diminish, scratch, and chip over a period of time due to normal use and therefore is not covered under the warranty.
9. Should a warranty claim become necessary, USR shall not be liable for loss of use, inconvenience, lost time, commercial losses or other incidental or consequential damages.
